#### **EXECUTIVE SUMMARY**

On November 14, 2023, Council approved a motion directing Administration to develop a pilot project permitting Off-Highway Vehicle (OHV) usage on roadways in Abasand. Following Council's approval of the OHV Pilot Project Plan for Abasand, public engagement took place from April 10 to 19, 2024. This engagement encouraged participation from various groups including schools, businesses, community groups, Indigenous Partners and residents of Abasand.

During the targeted workshop and online engagement, individuals had the opportunity to ask questions, express concerns, provide suggestions, and prioritize potential benefits and challenges. The feedback gathered will be reviewed as the bylaw is drafted and will serve as a valuable resource in establishing a baseline for measuring future success.



#### **NEXT STEPS**

- The Off-Highway Vehicle Pilot Project Bylaw will be read at Council for review and approval.
- Residents can <u>speak as delegates</u> on the OHV Pilot Project, which is expected to be presented to Council for final approval on June 11, 2024

#### Pending the approval of the bylaw:

- Education campaign
- The Off-Highway Vehicle Pilot Project Bylaw is anticipated to start near the end of June. The start date will be finalized once the Bylaw is approved. Once in effect a new <u>online engagement tool</u> will be available to residents to share feedback.
- 1-year public engagement check in (projected in 2025)
- Re-engage prior to bylaw expiry (projected for 2026)









#### Q1 - Are you an Abasand resident?




#### Q2 – Are you an OHV user?






#### Q3 – Do you access the OHV trails from Abasand?




#### Q4 – Do you use multi-use trails?





## Q6 – Do you see the benefit of OHVs having direct access to the Abasand staging area via Abasand roadways?




#### Q7 – Rank the potential concerns.






#### Q8 – Rank the potential benefits.





## Q9 – Share your comments or suggestions on the OHV Pilot Project in Abasand. (Overall sentiment\* of the 374 responses received)



\*Data is reviewed by the RMWB Public Engagement and project teams along with Social Pinpoint Analytics.

Sentiment indicates the overall emotional tone or sentiment of a text response, classifying it as positive, negative, neutral or mixed. Social Pinpoint analyses open-ended responses, automatically detecting sentiment, key phrases, official names and language information.



#### Q9 – Examples of long answer responses received organized by sentiment.

**POSITIVE:** I think this is a wonderful thing to do. Abasand is a great community where friends and neighbours are respectful to each other. With allowing the OHV on the roads to access trails I think it will cut down on the green space travelling. Which a lot of smaller kids use quite frequently for playing.

MIXED: I think it is a good idea, but the availability hours of the project should not be 24 hour as during later at night the noise levels are gonna be crazy.

**NEUTRAL**: We need to build separate trails next to the walking trails in other parts of town so everyone can access the trails. Not just Abasand. Thickwood for instance has no access at all.

**NEGATIVE:** I think it is a terrible idea and no one in city limits should have the expectation to use OHV on residential streets. It is proven unsafe for most OHV types to operate on pavement. I think it's a waste of time and resources. I don't think it will be successful because people push the boundaries and doubtful the rules are going to be followed.

### Example of suggestions received for the bylaw\*


- There should be a noise restriction.
- Increase fines for OHVs on green spaces.
- Invest in enforcement to ensure this program is a success and that everyone has an enjoyable experience.
- Suggestion to budget for more street cleaning.
- Suggestion to add speed bumps be pit on North
   Athabasca Ave to slow traffic and OHV too prevent
   potential collisions as this is already an issue.
- Build ATV trails throughout Fort McMurray connecting the different areas and policed by bylaw to ensure the rules are being followed.
- Have speed limits specifically for OHV 30 km/h max.
- If looking at expanding this to other urban neighbourhoods, suggest shortening their "staging distance".

- All green spaces and walking trails should have vehicle barriers to stop OHVs from having access to non ohy trails.
- Operational hours should be strictly restricted to 10 am until 6:30pm daily.
- Add a coin wash at staging area.
- Stronger punitive measures for noise offense
- Headlights and blinkers for traveling in the dark should be mandatory.
- Add a fine for OHV's bringing mud onto the roadways
- Build an OHV trail that surrounds Abasand instead of allowing them on the roadways.


Q2 – Are you an OHV user?


Q3 – Do you access the OHV trails from Abasand?


Q4 – Do you use multi-use trails?




Q6 – Do you see the benefit of OHVs having direct access to the Abasand staging area via Abasand roadways?

#### Q7 – Rank the potential concerns: Abasand participants






#### Q8 – Rank the potential benefits: Abasand participants

# Sample topics of discussion brought forward by participants:

#### Mandatory safety equipment and Traffic Safety Act compliance

- Can the RMWB list proper safety equipment for safe operation on roadways?
- Will officers have specific training / education?

#### **Enforcement and compliance**

- With the staging area across the street, can we get more enforcement presence in the front of the Ecole Boreal from 8:15-8:30 a.m.?
- Should speed limits be reduced?
- Will Bylaw enforce these rules on private roads? How will the RMWB assist with the enforcement on private roads?

#### Age and passenger restrictions

• Child passenger safety concerns: Safely transporting children in or on OHVs in traffic. How will this be enforced and is this safe?

#### Operational hours and areas

• No hour restrictions may result in noise complaints from community residents.

#### Licensing, registration & insurance requirements

• Will OHV's act like vehicles when on public roads?
